Our **Senior Adult Day Care Program** opened in 1985. It serves the frail elderly and those with Alzheimer's Disease. The goals of our program are:

- To provide a meaningful day for our clients.

- To improve the quality of life for the clients and their caregivers.

Admission Criteria

- Sixty years of age or older with preference given to Southold Town residents.
- Must be under a physician's care or will retain the services of one.
- Must have a stable home environment.
- Client must be able to receive benefit from the program.

Criteria for Discharge

- Incontinence and inability to handle personal hygiene even with assistance.
- Behavior which is not manageable in a group setting.
- The need for care surpasses the staff's ability to provide it.
- A discharge policy committee will decide the need for discharge. Family meetings will be held to discuss the reasons for discharge as well as alternatives.
